

On May 23, 2012, Plaintiff John Perkins was driving his 1987 silver Porsche 928 S4 Coupe in a parking lot when Defendant allegedly backed out of a parking space and impacted the left front side of Perkins' car. No one, thankfully, was hurt.

In April 2013, Perkins sued Defendant, demanding damages of \$15,910.28, the cost of repairs to the Porsche. At his February 2014 deposition, Perkins, who is a licensed lawyer, testified he bought the Porsche on eBay just a few days before the wreck in 2012, but could not remember the purchase price. In the summer of 2013, he sold it over the internet to a buyer from Seattle, but again he could not recall the exact price nor did he have copies of the bill of sale or other transaction documents. When asked by defense counsel if he could find the sales records or otherwise determine the transaction prices, Perkins repeatedly testified "it's possible." Perkins Dep. at 27-29. Defendant then sent written discovery to Perkins seeking more information about his purchase and sale of the Porsche, to which he replied he had none.

Defendant now moves for partial summary judgment, seeking a ruling that any damages awarded to Perkins be limited to his reasonable repair costs. Given Perkins' inability to produce evidence concerning his purchase of the Porsche and its post-accident sale, Defendant asserts Perkins should not be allowed to claim depreciation. Perkins resists, maintaining lost value is a

proper element of damages for personal property loss. He anticipates calling an expert witness at trial to testify how the wreck lessened his Porsche's value.

Perkins' inability to recall or provide documents concerning details of the sale of his car might strike some as odd. In his complaint, he declared the Porsche was "an all-original antique vehicle that has never been damaged nor repainted in any part." Complaint at ¶ 9. It is possible that a party—including one who is a lawyer—might forget basic details of the recent sale of a treasured item. It is also possible that a party, even a lawyer, might not have retained in his papers any record of what must have been a momentous transaction, or be able to access the records that may still exist electronically.

One could not deny the belief in such possibilities, but this court will proceed in a more rational direction, and grant Defendant's motion. Perkins is barred from presenting evidence of the Porsche's fair market value at trial from any source, whether by expert testimony or his own refreshed recollection.¹ A party who sells goods in the market cannot later come to court and dun another in damages for previous injury to the value of those goods while simultaneously frustrating inquiry into the market price obtained. Such conduct could justify a court to use its inherent power to toss the entire claim, which is what this court will do, with prejudice, unless Perkins on or before January 5, 2015, provides documentation concerning the price and other details of his original 2012 purchase and the 2013 sale.

IT IS SO ORDERED.





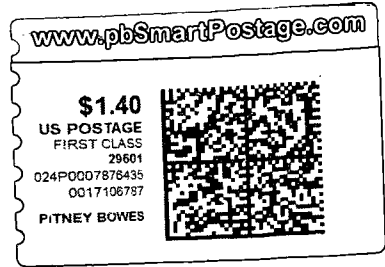
