

Pursuant to Rule 240(d), SCACR appellant moves for an order permitting waiver of the filing fee required by Rule 240(d), SCACR and any other costs and/or fees associated with the appeal of this case. In support of this motion appellant states:

1. I am the appellant in the above entitled case. In support of my motion to proceed without being required to pre pay fees or costs or give security therefore, I state that because of my poverty I am unable to pay the costs of said proceeding or to give security therefore, and I believe I am entitled to redress;
2. I am presently unemployed and receive zero dollars per month;
3. I was last employed in October, 2010 at the time I earned about one thousand six hundred dollars per month in wages. I was employed about five months in the year 2010;
4. In the past twelve months I've received zero dollars from no sources;
5. I do not have any money in my inmate trust fund account, checking or savings account;
6. I do not own any real estate, stock, bonds, notes, automobiles, or other valuable property; and
7. I wish the court to take into consideration that I've remained incarcerated since February 2, 2013.


