MOTION TO BE RELIEVED AS COUNSEL FOR APPELLANT

A lawyer may withdraw from representing a client if:...(5) the client fails substantially to fulfill an obligation to the lawyer regarding the lawyer's services or payment therefore and has been given reasonable warning the lawyer will withdraw unless the obligation is fulfilled.

See Rule 1.16(b)(5), of Rule 407 SCACR.

In support of this Motion, Jordan states that Appellant is indebted to Jordan for the legal services rendered in this matter (the lower court case and the appeal). Jordan has given reasonable opportunity to Appellant to make a satisfactory commitment to Jordan with regard to the outstanding obligation; and in response, Appellant suggested that Jordan move to withdraw as her counsel.

Jordan is therefore informed and believes that he is entitled to an Order immediately relieving Jordan as counsel for Appellant.






