

RESPONDENT’S MOTION TO DISMISS

Pursuant to Rule 240(a), SCACR, Respondent Wells Fargo Bank, N.A. (“Wells Fargo”) moves to dismiss the above-captioned appeal in its entirety. The basis for this motion is that Appellant Henrietta Rouse failed to timely submit the Record on Appeal and proof of service in violation of Rule 210, SCACR. As a result, this Court should dismiss the appeal.

The South Carolina Appellate Court Rules required Appellant to file the Record on Appeal “within thirty (30) days after service of the last brief.” Rule 210(a), SCACR. In the present case, Respondent filed its initial brief on October 13, 2014 and Appellant failed to file a reply brief. Accordingly, Appellant has failed to comply with her obligations. Thus, Respondent respectfully requests that this Court dismiss the appeal.



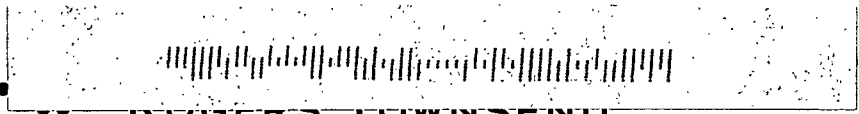
