

(2) There's no signature of Poe's indicating a wavier of, Presentment to the Grand Jury of the Sixteenth Circuit of York County,if in fact a grand jury was even impaneled to True Bill invalid indictments.

(3) There's (NO) language in the body of the Burglary Indictment First Degree,that indicates that the building was anything other than just that a building.

(4) Amended Indictment Number,2012-GS-46-03771 in which appears to be marked "True Bill" Dated,11-15-2012 here again signed by Paul Vehaun,and signed again by another Foreperson of the Grand Jury Kathryn Lee Neal Dated,5-16-2013.Here again there's (NO) language in the body of indictment that states that the building was anything other than that a building.


