FINAL ORDER OF DISMISSAL


This matter comes before the Court pursuant to an application for post-conviction relief (PCR) filed July 16, 2013. Respondent made its Return and Motion to Dismiss on or about February 27, 2014, requesting that the Application be summarily dismissed. Pursuant to this request, and after reviewing the pleadings in this matter and all of the records attached thereto, this Court issued a Conditional Order of Dismissal filed March 12, 2014, provisionally denying and dismissing this action, while giving the Applicant twenty (20) days from the date of service of said Order in which to show why the dismissal should not become final. Attached to this Final Order and incorporated herein by reference is an Affidavit of Service dated March 24, 2014, serving the above-mentioned Conditional Order of Dismissal on the Applicant.

The Applicant made no response to the Conditional Order of Dismissal within the twenty (20) day response period. This Court has reviewed the original pleadings and finds that a sufficient reason has not been shown why the Conditional Order of Dismissal should not become final.

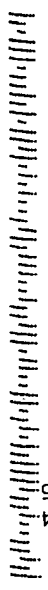
