**MOTION TO REQUIRE APPELLANT
TO ORDER TRANSCRIPT**

Pursuant to Rules 207 and 240, SCACR, Respondents Beal Lumber Company, Inc., and Palmetto Timber S.I. Fund c/o Walker, Hunter & Associates, Inc., hereby move this Court to require Appellant to order the transcript of the appellate hearing before the Appellate Panel of the South Carolina Workers' Compensation Commission held September 16, 2014. Pursuant to Rule 207(a)(1), SCACR, Appellant "shall, within the time provided for ordering the transcript, make satisfactory arrangements (including agreement regarding payment for the transcript), in writing with the court reporter for furnishing the transcript." Furthermore, "[u]nless the parties otherwise agree in writing, appellant must order a transcript of the entire proceedings below." Rule 207(a)(1), SCACR.


Respondents do not agree that the transcript of the hearing before the Appellate Panel of the Full Commission is not necessary, nor do they agree to Appellant ordering less than the full transcript. Because parties are limited to specific amounts of time for argument before the Appellate Panel, the transcript will not be voluminous. Respondents anticipate that they will cite to the Appellate Panel hearing transcript in their brief to this Court.

CONCLUSION

For all the reasons stated herein, Respondents respectfully request this Court to require Appellant to order the transcript of the full hearing before the Appellate Panel.



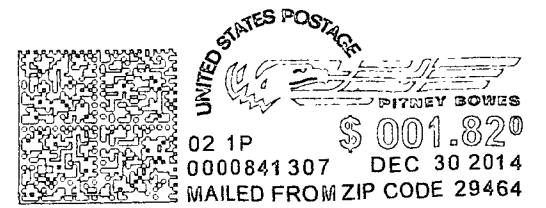
