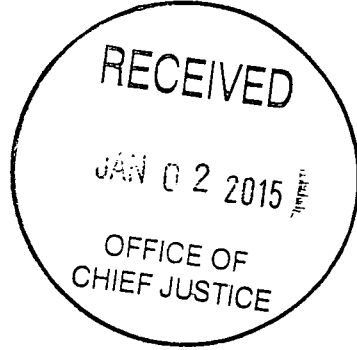

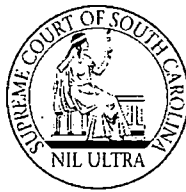
Jan indigent, unable to pay \$20.00 for a copy of the CD as

As to your question about the briefs, I can assure you that the members of this Court fully considered the brief submitted by your counsel in this case.

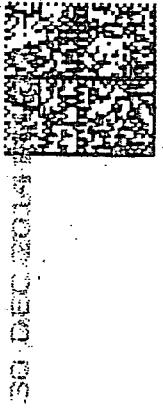
