
Dear Ms. Frierson

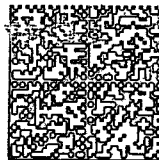
