
AMENDED NOTICE OF APPEAL



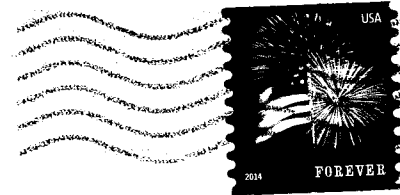
