As you are aware, the case of Nicholls & Crampton, P.A. vs. Estate of Valerie D'Agostino has been appealed to the South Carolina Court of Appeals. In accordance with Rule 207, SCACR, our office sent correspondence dated October 21, 2014 (copy enclosed) to Court Reporter, Deborah S. Please be advised that our office called Ms. Thomas on January 7, 2015 and January 8, 2015, and left a message, but we have not heard back from her.


