
**MOTION TO WITHDRAW AS ATTORNEY OF RECORD FOR RESPONDENTS



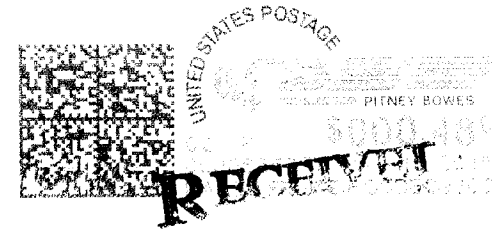
