

Statement of Facts

Now Comes, Richard K. Poe, filing Motion to Terminate the services of Robert M. Dudek.

(1) Counsel failed brief arguable grounds that arose during Post Conviction Hearing January, 22-2014. As the Judge failing to address the warrant and indictment claims, App 130, (17-25) 131, (1-10) App, 155(1-17) and 156, (1-10).

(2) Robert M. Dudek, has also failed to brief the issue of Judge Baxley failing to address the claim of Counsel Cronin failing to perfect appeal, and failing to comply to the Court of Appeals for necessary documents, causing appeal to be dismissed. See Post Conviction Relief Application.

(3) Counsel further failed to obtain necessary relevant material as transcript of hearing on April, 1-2013, in which was further mentioned during PCR hearing. See, App 124(16-22) 153, (11-20) also, 154(7-9)

(4) Robert M. Dudek has failed to brief all issues that arose during PCR hearing, depriving Richard K. Poe of his rights to adequate Appellate review.

Counsel on Appeal from denial of PCR is required to brief arguable issues despite counsel beliefs, Rule, 71.1(g).

Therefore, motion should be granted, and another Counsel be appointed to represent petitioner in his appeal for writ for certiorari.

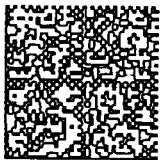
