

This matter comes before the Court on Plaintiff's Motion to Reconsider. A hearing on Defendants' Motion to Dismiss was held on October 15, 2014. Thereafter, an Order was filed on October 24, 2014 granting the motion. Plaintiff filed this Motion to Reconsider pursuant to Rule 59(e), SCRCF, on November 4, 2014. After careful consideration of the record in this case, it appears the Answer raises the defense of accord and satisfaction. Even though the signed release was presented to the court, further discovery is needed to gather all the facts surrounding the filing of the lawsuit after the release was signed. Accordingly, this Court hereby **GRANTS** Plaintiff's Motion to Reconsider. It is **ORDERED** that Defendants' Motion to Dismiss is **DENIED** without prejudice. Pursuant to Rule 59(f), the Court is of the opinion that oral argument is not necessary.



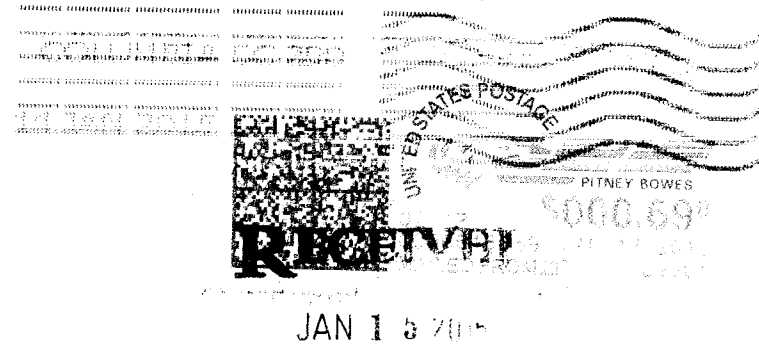
