Dear Mr. Shearouse:

Reference is made to the Supreme Court's Memorandum Opinion 2014-MO-045, and the reversal without prejudice of sanctions awarded to Respondent Shirley Hammer. Mrs. Hammer has since filed a Motion for Sanctions in the Circuit Court which is now pending before the Joseph M. Strickland. He requested that the parties determine if they could settle their differences in these cases. Counsel began engaging in those discussion this past Friday afternoon (January 16), and with the agreement of Ms. Ballard who represents Shirley Hammer, she and I are jointly requesting that the Court not issue any rulings on Mrs. Hammer's Motion for Costs filed with the Supreme Court on December 29, 2014, until after January 30, 2015.
