MOTION FOR AN EXTENSION OF TIME TO FILE
PETITIONER'S BRIEF PURSUANT TO
WHITE v. STATE

1. On November 20, 2014, this Court granted the petition for writ of certiorari and granted a belated appeal pursuant to White v. State. This Court directed the parties to brief the issues set forth in the Statement of Issues on Appeal attached to the petition. The deadline to file the brief pursuant to White v. State is January 21, 2015.



Counsel filed the initial brief of appellant and designation of matter in the case of State v. Alan Smith with the Court of Appeals on December 29, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Nicholas Macklen v. State with this Court on December 29, 2014.

4. This request is made in good faith and not for purposes of delay.

WHEREFORE, the undersigned counsel would respectfully request a thirty-day extension of time until **Friday, February 20, 2015**, to file the brief pursuant to White v. State.
