


Appellants hereby move pursuant to Rule 263(b), SCACR, for a 30-day extension of the time in which to serve and file Appellants' Initial Brief and Designation of Matter to be Included in the Record on Appeal in this case. The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. The deadline for service and filing of Appellants' Initial Brief and Designation of Matter to be Included in the Record on Appeal is currently February 2, 2015.
2. This is the first extension that the undersigned has sought in this appeal.
3. This appeal concerns a trial, and the length of the transcripts and volume of material in the record is thus greater than in many other appeals.
4. January has been a busy month for Appellants' counsel, who during this month has had a trial, written and submitted a brief to this court in a different case, and written and submitted a brief to the Supreme Court of South Carolina.
5. On January 28, 2015, Appellants' counsel has a previously extended brief submission deadline in another case in this court.
6. Appellants' counsel seeks a 30-day extension of this deadline in order to give him time to complete the brief.
7. Appellants' counsel does not anticipate seeking another extension.
8. Respondent's counsel has advised he is not authorized to consent to this extension.

9. Appellant's counsel believes there is good cause to grant the requested extension to March 4, 2015.

WHEREFORE Appellants pray for an Order extending the time in which to serve and file Appellants' Initial Brief and Designation of Matter to be Included in the Record on Appeal by 30 days, to March 4, 2015.


