
Dear Ms. Smith:

I write in response to your January 13, 2015 letter requesting notice of any conflicts with the listed potential dates in April for oral argument in this appeal (a copy of that letter is enclosed for ease of reference). I have a date-certain federal court trial set to begin on April 6, 2015, in the case of *Integrated v. Patton, et al.*, Civil Action No. 2:12-cv-03566-PMD. I believe that trial will take one week, while opposing counsel has opined to the court that he believes "it is not likely to take 2 weeks."
