MOTION FOR COSTS


Pursuant to Rule 222, SCACR, Kerry Levi requests that the costs of this appeal be taxed against Northern Anderson County EMS and Berkshire Hathaway Homestate Insurance Company, who were the respondents.

Rule 222(a) provides that when a judgement is reversed, costs shall be taxed against the respondent unless the court orders otherwise. This Court vacated the judgment of the Workers' Compensation Commission on June 30, 2014, and the Court issued the remittitur January 20, 2015. Because the Court has not ordered otherwise and because the parties have not agreed otherwise, the rule provides that the Court should award costs to Kerry Levi, who is the appellant.

In accordance with the instructions of Rule 222(d), an itemized statement of costs is attached to this motion.




