


Dear Bonnie:

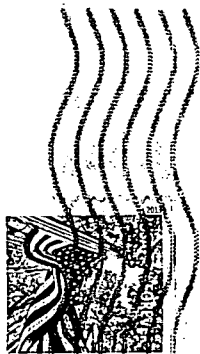
