
Pursuant to Rule 207 (b), SCACR, the Appellants believe that their initial brief and designations are due on or before February 13, 2015.





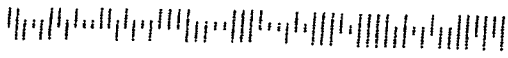
