On Friday, September 26, 2014, I learned that Mr. Dan Ward, Appellant in the above-captioned matter, filed his Initial Brief and Designation of Matter with the Court. The date of his filing was September 3, 2014, and based on the cover letter, Mr. Ward claims to have served me with a copy.


