The South Carolina Supreme Court has held: IN THE MATTER

OF HADDOCK, 321 S.E.2d 601 (S.C.1984) (a defendant's criminal case file "belongs" (emphasis added) to the defendant and should be forwarded to the defendant within a reasonable time upon a written request). Also review: MATTER OF CROOSLAND 270 S.C. 546, 243 S.E.2d 198 (S.C.1987).

Violation of this request, not only is a closed-eye approach to the above Supreme Court rulings; but violates the Supreme Court's Code of Professional Responsibilities, a lawyer obligation to his/her client.

I sincerely look forward to receiving my criminal case file in it's entirety within a reasonable time, and I respectfully thank you very much for your cooperation in this matter.

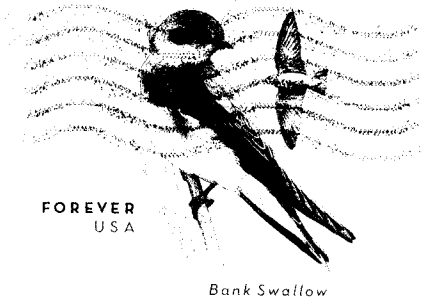
