That in Sumter County, South Carolina, on or about October 29, 2013, the Defendant, **LYNDON O'BRIAN ALLEN**, did manufacture, distribute, dispense, deliver, purchase; or did aid, abet, attempt, or conspire to manufacture, distribute, dispense, deliver, or purchase; or did possess with the intent to manufacture, distribute, dispense, deliver, or purchase a controlled substance or a controlled substance analogue, to wit: Heroin; in violation of 44-53-370 of the South Carolina Code of Laws (1976) as amended.

COUNT TWO

ATTEMPT AND CONSPIRACY, DRUG LAWS

That in Sumter County, South Carolina, on or about October 29, 2013, the Defendant, **JENNIFER TERESA McCAULEY**, did combine, conspire, confederate, agree or have tacit understanding with another, for the purpose of committing a crime in violation of the drug laws; to wit, distribution of heroin, in violation of Section 16-17-410, Code of Laws of South Carolina, (1976, as amended).

POSSESSION OF A SCHEDULE I-V CONTROLLED SUBSTANCE

That in Sumter County, South Carolina, on or about January 24, 2014, the Defendants, **ISIAH JEROME WILLIAMS and LYNDON O'BRIAN ALLEN**, knowingly or intentionally and unlawfully did possess a quantity of Acetaminophen/Hydrocodone, Dilaudid, Morphine, Clonazepam and/or Diazepam, a Schedule II, III or IV controlled substance, all in violation of § 44-53-370 of the Code of Laws of South Carolina (1976), as amended.

COUNT FIVE ✓

POSSESSION WITH INTENT TO DISTRIBUTE COCAINE

That **ISIAH JEROME WILLIAMS and LYNDON O'BRIAN ALLEN** did in Sumter County, on or about the January 24, 2014, possess with intent to distribute, dispense or deliver, or did aid, abet, attempt or conspire to distribute, dispense, or deliver a quantity of Cocaine, a controlled substance under provisions of Section 44-53-110, et. seq., Code of Laws of South Carolina, 1976, as amended, such possession not having been authorized by law, and being in violation of Section 44-53-370(b)(1), S. C. Code of Laws, 1976, as amended.

POSSESSION OF ECSTASY/MDMA/METHYLONE

That **ISIAH JEROME WILLIAMS and LYNDON O'BRIAN ALLEN** did in Sumter County on or about January 24, 2014, knowingly and intentionally possess a quantity of Methylenedioxymethamphetamine (Ecstasy) and/or Methylone, a Schedule I Narcotic under provisions of Section 44-53-370, et. seq., S. C. Code of Laws, 1976, as amended, such possession not having been authorized by law, in violation of Section 44-53-0370(d)(2), S. C. Code of Laws, 1976, as amended.

COUNT SEVEN

POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME

That **ISIAH JEROME WILLIAMS and LYNDON O'BRIAN ALLEN** did in Sumter County, on or about January 24, 2014, possess a firearm, or visibly display what appeared to be a firearm, or visibly displayed a knife, during the commission or attempted commission of a violent crime, specifically while Trafficking in Cocaine Base, in violation of Section 16-23-0490, S. That in Sumter County, South Carolina, on or about January 24, 2014, the Defendants, **ISIAH JEROME WILLIAMS** and **LYNDON O'BRIAN ALLEN**, knowingly did sell, manufacture, deliver, purchase, or bring into this State; or did provide financial assistance or otherwise aid, abet, attempt, or conspire to sell, manufacture, deliver, purchase, or bring into this State; or did possess or attempt to possess a controlled substance or a controlled substance analogue, to wit: Cocaine Base, in excess of ten (10) grams; in violation of 44-53-375 of the South Carolina Code of Laws (1976) as amended.

COUNT TWO

POSSESSION WITH INTENT TO DISTRIBUTE MARIJUANA

That in Sumter County, South Carolina, on or about January 24, 2014, the Defendants, **ISIAH JEROME WILLIAMS** and **LYNDON O'BRIAN ALLEN**, unlawfully did possess with intent to distribute, dispense, or deliver a quantity of marijuana, a controlled substance under provisions of Section 44-53-110, et seq., Code of Laws of South Carolina (1976), as amended, or did otherwise aid, abet, attempt, or conspire to manufacture, distribute, dispense, or deliver marijuana, all in violation of Section 44-53-370, Code of Laws of South Carolina (1976), as amended.
