Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Darrin Bryant v. State in this Court on December 8, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Mykel Watkins v. State in this Court on December 5, 2014.



4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


WHEREFORE, the undersigned counsel would respectfully request a **final thirty-day extension, until March 4, 2015**, in which to file the petition for writ of certiorari and


