COMES NOW, Respondent, South Carolina Department of Corrections (Department), and requests that this Honorable Court grant Respondent leave to file its Initial Brief and Designation of Matter out of time. In support of this request, Respondent would show unto this Honorable Court the following:

1. This matter comes before the Court by way of Appellant’s appeal of the ALC’s decision affirming Respondent’s decision to uphold Appellant’s July 26, 2013 disciplinary conviction.
2. On December 10, 2014, Appellant filed his initial brief and designation of matter.
3. However, Respondent took note of the Court’s deficiency letter dated December 11, 2014, which stated that Appellant had failed to include a certificate of service for his

designation of matter. Respondent flagged Appellant's file and put a note that Appellant had an uncured deficiency. As of today's date, that deficiency has not yet been cured.¹

4. Respondent's Initial Brief and Designation of Matter have been submitted contemporaneously with this motion, and it is Respondent's contention that Appellant has not been prejudiced by the delay in submitting the Respondent's Initial Brief and Designation of Matter.

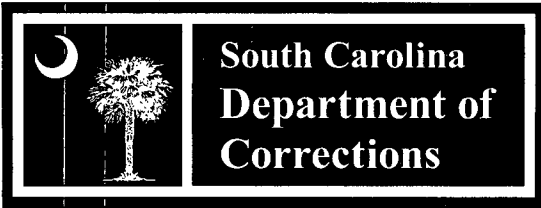


