**APPELLANT’S MOTION FOR EXTENSION OF TIME**

Pursuant to South Carolina Appellate Court Rule 263(b), Appellant The Charlotte-Mecklenburg Hospital Authority, d/b/a Carolinas Medical Center-Fort Mill, moves for an extension of thirty (30) days from the existing deadline to file its Initial Brief in this matter. Appellant filed its Notice of Appeal on January 14, 2015. Appellant’s Initial Brief is now due on or before February 13, 2015. Appellant requests an extension of thirty (30) days to file the Initial Brief on the grounds that the transcript in this matter is extensive, covering several weeks of testimony and argument and consisting of nearly three thousand pages of testimony and hundreds of exhibits. As



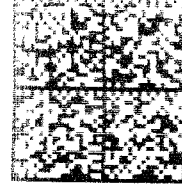
