
NOTICE OF APPEAL

The South Carolina Property and Casualty Insurance Guaranty Association (“Association”) hereby appeals from the following orders and/or judgments of the circuit court in the above matter: (1) the Order granting the Motion for Summary Judgment filed by Respondents Janette Buchanan and Shana Smallwood, individually and as Co-Personal Representatives of the Estate of James S. Buchanan (“Respondents”), and denying the Association’s Motion for Summary Judgment filed September 10, 2014 (“Summary Judgment Order”) (attached as **Exhibit A**); and (2) the Form 4 Judgment in a Civil Case denying the Association’s Motion for Reconsideration of the Summary Judgment Order filed January 22, 2015 (“Reconsideration Order”) (attached as **Exhibit B**).

The Association received written notice of entry of the Summary Judgment Order on September 15, 2014, and timely served its Motion for Reconsideration on September

25, 2014. The Association received written notice of entry of the Reconsideration Order on January 29, 2015, and, therefore, this Notice of Appeal is timely.
