Then around 10:30pm we went back and got Antomio. The four of us went riding. Terrance was the driver. Terrance say he had a motel room- I don't know where but he had the key. We was looking for women. We were coming down Walnut St. and we saw the car with the lights out. It was a X BMW and was silver. I was in the back left seat of the blue Cheverolet XCelebrity, Antonio was in the front left, Monta was behind the driver, and Terrance was driving the car. Terrance said there was a couple of girls driving the car. We thought they was white girls. Terrance say lets stop and see who it is. Then we seen it was two boys. Terrance said Y'all want to get them? I said I didn't want nothing to do with that. Antonio said Lets do it. He meant let's rob 'em. Me and Monta wasn't saying nothing. The BMW pulled into a driveway. Terrance pulled up behind them and tried to block them in. Antonio asked Terrance to let him hold the gun. Terrance had a 4-Barrel gun .357 he stopped on Stonewall at a house. This was when it

Antonio had paged me earlier and told me that he was coming by for me. Antonio was driving his chevrolet cavalier color blue, we carried my two cousins to Southland Park to their mothers house, their mother is Jackie Baxter. We then left there and went to Tony Brice house, he also live in Southland Park, I went to his house to get a few dollars for gas for Antonios car, but Toney said that he did not have any money. We then left his house and drove to our grandfathers house on Vernsdale Road, our grandfather is Willie Ed Gordon. We rode around for a good part of the day, and we saw Anthony Lowery, and we all asked him where did his brother Albert keep his gun, because Albert always carried the gun around before he was arrested about a week ago for a drug violation. Anthony told us it was in Jay Neelys back yard in the bushes near a light post, but said that Jay did not know it was there, Jay also live in Southland Park. Gary and myself went and got the gun, it was a 357 magnum and a 38 special combined, it had four barrels. When we got back to the car we gave the gun to Monta Gordon. We went back to our grandfather house on Vernsdale Road and worked on his car radio.

Monta & Antonios girlfriends wanted to shoot the gun so we allowed to shoot it one time. We left there and rode around willowbrook for awhile, We also rode to the apartment complex behind the Tech looking for my uncle, but we did not locate him, we left and was riding through workman street and then we drove up Walnut street to Jones Ave. We saw a car driving past us with the head lights off, this was after midnight. this was a grey or silver BMW, I was driving at the time so I blinked my light to tell the driver his lights was off. There were two white males in the car. I then said man if I had the gun I would rob them guys, The men in the BMW pulled into a driveway on Jones Ave, I pulled near the and told them again that their lights was off, as I was going to drive off Antonio began asking them if they wanted to smoke some weed, first he asked them if they had some weed to sell, meaning marijuana. If they had any weed we was going to rob them of it. I was pulling off in the car and the guys in the BMW backed out into the street, then Antonio jumped out of the car and ran up to the drivers side of the BMW and asked ~~###~~ them if the car was stolen, and then he asked them if they had any money, the two guys said no. Gary was with Antonio, Monta and I was telling them to come on and lets go, then we heard the gun fire. Antonio and Gary then ran and got back in the car. We began asking Antonio why did he do that, and he was pointing the gun at all of us I drove down the street and then I let Antonio drive his car. We went down on Crawford Road near where the new houses had be builded. Gary and Antonio got out and went up the street and later came back with amplifier, I dont know where it came from and I did not ask. We went back to my grandfathers house on Vernsdale Road and worked on the radio until around 4:30AM and then everyone said that they was ready to go home. I had asked Monta to take me to my mothers house up near York SC. As we were driving near Bynum Ave, an unmarked police car got behind us and continued to follow us, so Monta took off real fast in the car when the blue light in the unmarked car came on. Gary and I jumped out on Constituio Blvd near the park. Monta kept going. Later Gary and I went to Lakishas house at 290 Fargo street, and thats where we was arrested at. Lakisha and Tawana was also arreste The police found the pistol in the kitchen at Lakishas house, Gary must have put the gun where the police found it.

Terrance say it was two girls in the car and they was riding up the street with no lights on. Then we figured out that it was two boys. We heard some music like and Junebug heard the music and said he had to have the car. Junebug gave me the gun and told me to get the BMW. So I took the gun. The BMW was in a driveway and Junebug (Terrance) blocked them in. I went up to the drivers window and I told them I wanted their money. They say they din't have no money. I was holding the gun pointed at them sideways like. I told them get out the car because my boy want the car. Monte was standing next

I had only shot that gun once before and I don't really know how it works. I wished I could have got the bullets out but it went off. I thought the guy got hit in the leg. The BMW was driving straight. At first I didn't know where the bullet went because the car kept going. Then we all got back in my car. Terrance was sitting in the car the whole time but he was trying to talk junk to them from the car. Then we went to the country to my house on Vernsdale. Then Monte took the car to the other boys home. The next thing I know is the police chasing my brother because the car got chased back to my house. AG

I want to add that I want to make this statement and I have been offered the opportunity to have my grandmother or mother with me but I just want to tell the truth now and get this over with so I don't need no one with me. Captain Cabaniss asked me if I wanted someone from my family or a lawyer with me but I'm being truthful about what happened and I'm sorry for it. Last night July 22nd, 1998 about 8:30-9:00PM Junebug McCreary, Gary Moffatt and my brother Antonio Gordon came over to my grandfather's house. Me and Antonio both live with him. All 3 guys started working on my brother's car, a blue Chevrolet 4dr. After they got finished working on the car they all wanted to leave and go riding around. Me, Antonio, Junebug and Gary Moffatt left and went riding around. Junebug was driving and we all stopped by a house in Southland Park. We passed by the Glenn's and went to the 3rd or 4th house on the right and he said he was going to pick up his gun. He went inside the house and got the gun and came right back out. He had the gun in his right back pocket. We rode on down the street and he pulled the gun out. It was a 4 barrell chrome pistol with brown handles. He put the gun back in his pocket and went to his grandmother's house and got the bullets. She lives on S. Stonewall St. He went inside and came right back out again. The gun was already loaded, but he said he needed some more bullets. Junebug was driving the whole time. We rode around some more and wound up on S. Jones. We all saw a BMW that was silver or grey and the people in the car didn't have the lights on. Junebug said that the car must be stolen and he was going to steal the car from them. He blinked the lights to let the people know their lights weren't on. Junebug was driving and Antonio was in the front passenger seat. I was in the backseat behind the driver and Gary was in the backseat behind my brother. After Junebug blinked his lights the car pulled into a driveway and Junebug pulled up past the car and then backed up so the car couldn't back up. Antonio and Junebug asked them if they smoked weed. They said not right now.
