
**RETURN TO RESPONDENT'S MOTION TO AMEND DESIGNATION OF MATTER





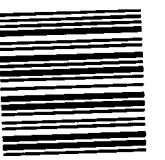
