
I received a letter today from my client, Bobby Russell, regarding the recent transcript of record. He brought to my attention a number of concerns that he had with this transcript. I have summarized his notes and I would appreciate it if you could verify that this transcript is correct.

1. Page 3, line 13, it says Claude Ricco and Todd Fuller, I believe this should read Ricky Urrichio and Chad Fuller.
2. Page 3, lines 19-20, I believe that this is incorrect. My client was sentenced to 15 years suspended to 3 years with time served.
3. Page 8, lines 3-6, there appears to be testimony missing.
4. Page 8, lines 7-15, there appears to be testimony missing from this section.
5. Page 10, lines 8-16, there appears to be testimony missing from this section.
6. Page 15, line 23, this should be Lori Lewellen.
7. Page 18, lines 3-5 there appears to be some discrepancy regarding the dates of September, 2008 and April, 2008.
8. Page 18, line 17 says Malphus. I do not know who Malphus is.
9. Page 20, lines 15-18, this sections seems to be out of context with the rest of the transcript.
10. Page 23, line 11, this should be a personal friend.
11. Page 24, lines 9-12, my client does not remember this testimony.
12. Page 25, lines 7-10, this paragraph is difficult to follow regarding what is being testified too.
13. Page 28, lines 4-6, this section appears to have something missing from this statement.
14. Page 29, lines 8-10, it doesn't appear that all of the response is included on line 9.
15. Page 30, lines 1-2, this sentence is unclear.
16. Page 30, lines 10-11, my client indicates to me that he does not remember testifying to this fact.

17. Page 31, lines 20-21, it mentions Dr. Hurt and I believe it is supposed to be Dr. Burke.
18. Page 34, lines 19-22, I appreciate it if you could check the record to see if this statement was actually made.
19. Page 35, lines 18-20, I would like you to check the record to see if this statement was made.
20. Page 35, line 24, that should be Dr. Burke.
21. Page 36, lines 3-13, I would appreciate if you could check this for accuracy.

I would appreciate your understanding and consideration in this matter. I have attached a copy of the transcript for your convenience.
