1. The time for filing the Respondent's Initial Reply Brief is February 9th, 2015, based upon the


Certificate of Service of the Respondent's Initial Brief.



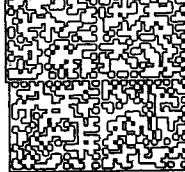
