Since I received the letter from Attorney Sammataro notifying me of some errors that need correcting, I need to submit another Designation of Matter. I didn't know that he was the one who was to critique the Records on Appeals.

Office Depot is in the process on inserting the missing pages that they inadvertently left out although they had all of the pages in their possession and placing new cover sheets on the Volumes since I numbered each Volume from 1-8. I am in the process of renumbering some pages since I had to remove some pages from the Records on Appeal.

Unfortunately, the Form 50 for July 23, 2007, Request for a Hearing for WCC Claim No. 9503744 is not inserted in the Records of Appeal nor is the second page of Form 51, Employer's Answer (WCC Claim No. 0321756) of March 10, 2006.

I obtained four pages of a Form 50 of July 23, 2007, from Attorney Carter; but this Form which had the accident date of October 24, 2004 was a mistake. The date of the accident was October 24 1994. This form that was file for July 23, 2007 was for my second fall at Trident Hospital which occurred on October 24, 1994. This Form 50 is not part of the Cases on Appeal. I don't remember what number was given to it by the Worker's Compensation Commission. Since this Form does not go with the accident WCC File No. 9503744, I couldn't include it in the Records on Appeal. I never received any other documents from Attorney Carter. I sent an e-mail to Attorney Sammataro for the send page of his Form 51, but I don't think that I received it. I believe he was angry with me. I was unable to read an e-mail that he sent to the other attorneys.
