

Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of State v. Julio Hunsburger with the Supreme Court, on January 16, 2015. Counsel had an oral argument in the case of State v. Danny Ryant in the Supreme Court on January 13, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


