RESPONDENT'S SECOND MOTION TO SUPPLEMENT THE RECORD ON APPEAL

TO THE HONORABLE COURT OF APPEALS OF SOUTH CAROLINA: NOW COMES THE Respondent Bank of America f/k/a Countrywide Home Loans, d/b/a America's Wholesale Lending, pursuant to Rule 212(b) of the South Carolina Rules of Appellate Procedure, respectfully moves this Court for an order allowing Respondent to supplement the Record on Appeal with the following document:

1. Form 4 Order Dismissing Motion to Alter to Amend Order Pursuant to Rule 60(b), dated June 20, 2014.


Respondent requests that the Form 4 Order dismissing Motion to Alter to Amend Order Pursuant to Rule 60(b), dated June 20, 2014 be added to the Record on the Appeal on the basis that said order has been cited in Respondent's initial brief and the Appellant's original Motion to Alter to Amend Order Pursuant to Rule 60(b) is currently included in the Record on Appeal. (R. pp. 31-33).

The current Record on Appeal in this matter includes the Appellant's original Motion to Alter to Amend Order Pursuant to Rule 60(b). (R. pp. 31-33). Also included is the Form 4 Order denying Appellant's Motion to Reconsider. (R. pp. 34-35). However, the Appellant's original

Motion to Reconsider was not included in the Record on Appeal. Respondent subsequently supplemented the Record on Appeal to include the Appellant's original Motion to Reconsider. (Supp. R. pp. 3-4). The current Record on Appeal in this matter excludes the Form 4 Order dismissing Motion to Alter to Amend Order Pursuant to Rule 60(b), dated June 20, 2014 and it is necessary to supplement the Record on Appeal to include for consideration the order displaying the trial court's ruling on said motion. A copy of the Order dismissing Motion to Alter to Amend Order Pursuant to Rule 60(b), dated June 20, 2014 is attached and incorporated herein as Exhibit "A."

Respondent discovered this omission while inserting citations to Respondent's Supplemental Record on Appeal filed February 2, 2015 during the preparation of its amended Final Brief pursuant to this Court's order dated January 8, 2015. Respondent has prepared its amended Final Brief, with the exception of a citation to the omitted order, and has discovered no further material missing from the Record on Appeal in this matter.

WHEREFORE, Respondent Bank of America f/k/a Countrywide Home Loans, d/b/a America's Wholesale Lending request this Court grant its Motion Supplement the Record on Appeal.




