I am so sorry to learn of the passing of Harold. It was always a pleasure to speak with him.


I had earlier informed Harold that in order to continue the appeal, the Court of Appeals is requiring that the Personal Representative of Abe Chapman's estate must be substituted as a party since a Power of Attorney terminates upon death of the principal (Abe Chapman). 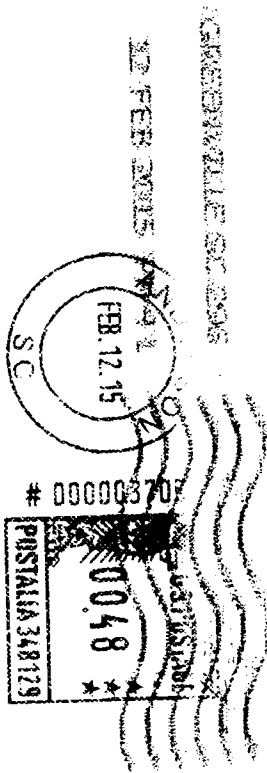
