DUE TO HEALTH**





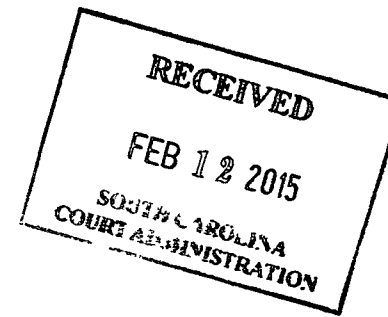
