State That a motion for Extension of time needed to be filed within 10 days of the letter.





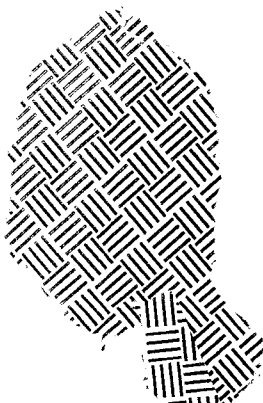
