

Pursuant to South Carolina Appellate Court Rule 263(b), Appellant moves for additional time to file its Initial Brief in this matter. 

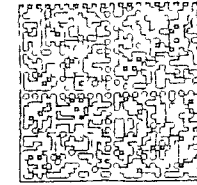
