1. On February 23, 2015 Appellant filed a “Motion to Supplement The Record” to bring to the Appellate Panel’s attention a significant new legal authority which did not exist at the time the final briefs were filed. Appellant proposed to present this as a Supplement to the Record on Appeal per SCRAP Rule 212.
2. At the time this Amendment to Appellant’s Motion was filed (mailed), no responsive pleading had been received from the Respondent.
3. Appellant is of the belief that SCRAP Rule 208(b)(7), Supplemental Citations, suggests a more appropriate format to present this most recent legal authority to the panel, to wit, provide a single page with the citation together with the issues and page numbers (of the Brief and Reply Brief) to which they apply.
4. The reasoning of Appellant’s (original) motion is unchanged; Appellant has simply found a better format in which to incorporate this Citation into the Appeals Package.
5. Appellate thus modifies the relief requested, suggesting that instead of a Supplemental Volume of the Record on Appeal a simple Citation Page be allowed conforming to the format stated in SCRAP Rule 208(b)(7).


