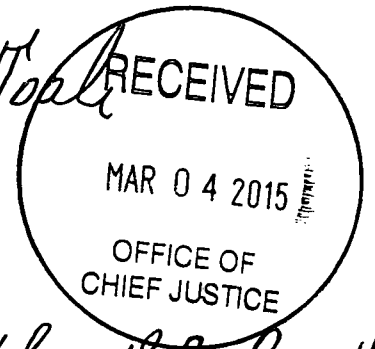

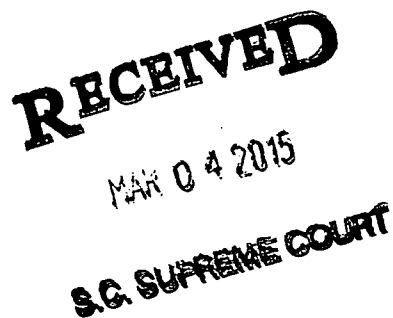

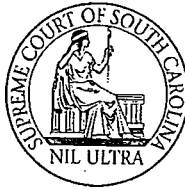

Rule 227(b) SCACR

Within (30) Days of receipt of the transcript, petitioner must serve a copy of the appendix and a petition for writ of certiorari on opposing counsel and file with the clerk of the Supreme Court an original plus (6) copies of the petition, two copies of the appendix, and proof of service showing the appendix and petition have been served.

For some reason this rule of the court is not being followed in the above mentioned case. These rules are clearly listed in the Second Edition of Appellate Practices in South Carolina; by you the Hon. Jean Hofer Toal, Shahira Vafai, and Robert A. Tuckersmith. If possible, could you or one of your fine staff respond back to me concerning this very important matter. 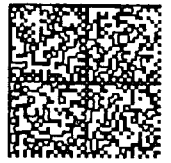
