THERE WAS SEVERAL OTHERS THERE REPRESENTED BY HIM AND I KNOW ONE OF THEM I BELIEVED FIRED HIM AS THEIR ATTORNEY. HE WAS SUPPOSE TO HAVE CALLED ME ABOUT 2 WEEKS AGO AND I HAD A ORDER TO REPORT TO OPERATIONS THAT DAY AT 8:30 AM AND HE WAS SUPPOSE TO CALL ME AT 9:00 AM. I WAITED TILL 10:00 AM. NO CALL FROM HIM. TWO COUNSELORS HERE AT THE ICS INTERMEDIATE CARE SERVICE FOR MENTAL HEALTH PEOPLE. I HAVE CALLED HIM TWICE LEFT MESSAGES AND SENT TWO LETTERS TO HIM AND STILL NO CALL FROM HIM OR NO RETURNED LETTERS FROM HIM. HE STATED IN THE LETTER I GOT FROM HIM DATED JUNE 23<sup>RD</sup> 2015, POSTMARKED JUNE 23<sup>RD</sup> RECEIVED FEB 4<sup>TH</sup> AT KIRKLAND MAIL ROOM AND I RE-

I received it Feb 5<sup>th</sup>, 2015. I was given 20 days from  
 the date of this letter to get my Pro Se Explanation  
 into you which you give me an extension on  
 which I do appreciate it. My Attorney stated  
 in this letter if I have any questions or con-  
 cerns to not hesitate to contact him. I did

 file him as attorney since he is court appointed

 plain like you would want me to and I never  
 had a mental examination before my hearing

 & so I then knew this man and I was threatened  
 by a cousin to this man that got killed that  
 worked in the county jail that threatened my

BLESS YOU IN CHRIST'S ~~JEFF~~ NAMES.

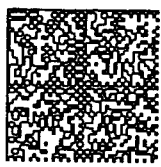

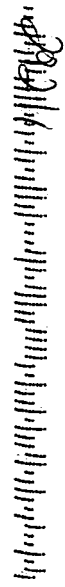
