Dear Ms. Frierson,

I am writing you in regards to my trial transcript,
and 3 other transcripts of my pre-trial hearings.
I wrote you on September 18, 2013 after receiving
my transcripts on September 17, 2013. Since then I
have examined them more thoroughly. The following
list is of all the alterations, additions, and omissions
that I noticed:

Transcript of Hearing (CIA# 201-GS-45-0095)

- The first omitted testimony I noticed is on page 109. During Maurice Smith's testimony he stated he saw a "small gun" fall from my waist during a fight prior to the incident. This statement is missing from the transcript. Next on page 125, Maurice Smith's testimony is altered from denying talking to S.H.E.D. investigators on February 13, 2012, to him stating he doesn't remember talking to them. Next is in Levar Wesley Walker's cross-examination starting on page 154. Mr. Ballenger presented numerous exhibits of pictures of the clothing recovered from the vehicle I was driving, in which Mr. Walker testified the suspect was not wearing. Somewhere in between pages 219 and 221 is missing testimony of Detrel Matthews stating where he and the victim were standing when I came up to Mr. Matthews and shook his hand, and how he didn't see me go shake hands with Maurice Smith. On page 311, line 14 - page 313, line 3 I'm 100% certain was not said at my trial. There was an objection that was made by the prosecution on

page 326 between lines 2 and 3 that is missing. The testimony starting from page 332, line 4 - page 333, line 24, I know for a fact never took place. O'Neal Matthews nor the details of Wayne McFadden's November 4, 2010 Incident Report Supplemental were never mentioned in anyone's testimony at my trial. On page 354, line 24, I never said "...yeah". On page 355, line 9, I never said that was my car on the tape. On page 362, line 21, I never said what brand of .38 special I had. On page 418, lines 13-14, and 23-24 are rearranged and missing a very important statement made by solicitor Kimberly Barr. Ms. Barr's line of questioning went, "And the police cleared you of this crime right?", and next stated, "And you actually took and passed a polygraph examination right?". This is vital to perfecting my appeal.
