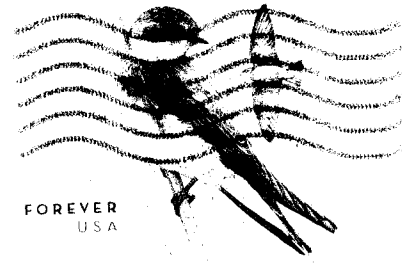

Bank Swallow

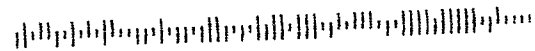
