
Further, appellant did not provide pinpoint cite information (a reference to material on specific page number within a document) in his citation of case laws,





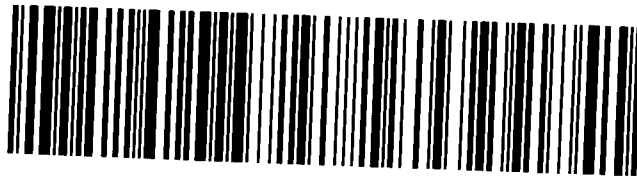
