Appellant Ostendorff respectfully moves to this Court, pursuant to Rule 263(b), SCAR, Motion To Extend Time To Final Brief.


Ostendorff was to file Appellant's Final Brief on February 25, 2015. Appellants requests and additional 20 days to file Final Brief , by March 17, 2015.


