



If you have any other questions regarding this matter, please do not hesitate to contact us.

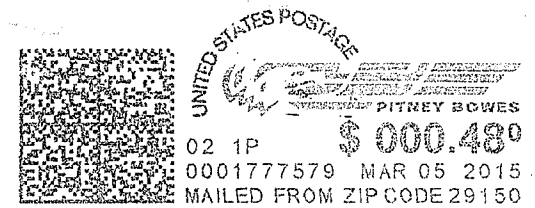

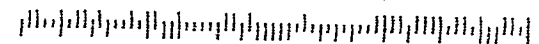

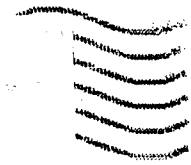
