


NOTICE OF APPEAL



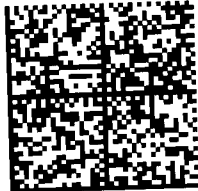
