Dear Mr. Spell:

I am, Tameika Givens, the appellant-defendant in the above-referenced matter. I have tried relentlessly, to no avail, to ascertain truthful and accurate information about the number of hearings and/or trials (if any) and the identity of the court reporter(s) (if any) to allow me to request and receive copies of the transcript(s) regarding the above-referenced case.

On November 24, 2014, I finally got the opportunity to communicate with Ms. Stacey Scaggon (who purportedly served as the court reporter for the above-referenced matter). Interestingly, Stacey Scaggon made at least three very startling statements about herself and her involvement and knowledge about this case:

1. Scaggon served as the court reporter for Judge Mikell Scarborough during the time the above-referenced case was under the auspices of the State of South Carolina County of Charleston Court;
2. Scaggon would have been the court report present at any hearing or trial held regarding the above-referenced matter; and
3. **No hearing or trial was ever held regarding the above-referenced case.**

Nonetheless, the court records indicate that there were at least two hearings or trials regarding the above-referenced matter (allegedly held on June 9, 2014 and a "Final Hearing" on July 2, 2014 respectively).

Perplexed by Ms. Scaggon's assertions, I sought the assistance of other court staffers.... When I spoke with Ms. Desiree Allen (the Court Reporter Manger at the State of South Carolina County of Charleston Court) on December 15, 2014 about the intentional action and inaction of others and the difficulty I have encountered/am encountering regarding my request for the transcripts. Ms. Allen immediately called Ms. Scaggon to inquire about the transcript request. Ms. Scaggon informed Ms. Allen that no hearing or trial was ever held regarding the above-referenced case. Thereafter, Ms. Allen called and emailed me in which she explicitly explained that Ms. Scaggon was the assigned court reporter for the above-referenced case but no hearing or trial was held and therefore I cannot receive a transcript because the court never held a hearing or trial regarding the above-referenced case.

Now, this quest for the transcript(s) have been further complicated since you (Jeffrey Spell, the plaintiff's attorney) recently informed the Appellate Court of South Carolina (on/about February 2015) that Ms. Stacey Scaggon served as the court reporter for a trial held on June 9, 2014 for the above-referenced case. But again in November 2014 and in December Ms. Scaggon unequivocally stated that there was never a hearing or trial held regarding the above-referenced case. See attached email communication particularly, page 21 of 28.

My rights as the appellant-defendant have been thwarted from inception and throughout this case (e.g., denial of due process; defective service of process; biased unilateral/ex-parte nomination and appointment of the guardian ad litem; failure to provide discovery; unauthorized refiling of my documents; irreconcilable assertions about whether any hearing(s) and/or trial(s) were actually held; and impedimenta to my request for the transcript(s)). The single and cumulative intentional actions and inaction as well as the negligent actions and inaction that have unjustly impeded my right to litigate this case fairly before the State of South Carolina County of Charleston and the Appellate Court of South Carolina is nothing less than grave injustice.

I have attached copies of the following:



So, if you have not had the opportunity to forward copies of any and all transcripts as well as any correspondence and/or communication between yourself (or by another on your behalf) with any court reporter or anyone responsible for or has access to creating, maintaining and/monitoring court records (audio or written) and any outstanding documents regarding this matter then kindly do so.

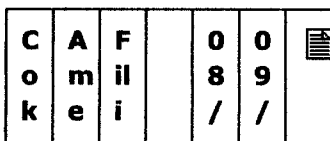

I am sending this email as a follow-up to my conversations with Judge Scarborough's current court reporter regarding my request for the transcript of the above-referenced matter. Initially, I contacted her to request the transcript and she directed me to contact the court reporter(s) who presided over the hearings/case. 
