MOTION REQUESTING PERMISSION OF THE COURT TO CORRECT THE RECORD ON
APPEAL

I am submitting a request to the Appellate Court for it to please grant my motion to correct the Record on Appeal.

After the Record on Appeal was bound and the 14 bound copies and the unbound copies submitted to the Court and the opposing attorneys copies delivered, The opposing attorney Sammataro pointed out to me some mistakes that were inadvertently and needlessly made. There was a need to correct these errors and mistakes for the accuracy of the Record on Appeal. The Court was notified of these errors, but the Appellant was not aware that she had to get permission to correct these errors and mistakes. Therefore, a Motion has been subsequently submitted.

The following errors had needed to be corrected:

1. The renumbering of the volumes from Volume I-4 with two parts to each volume, to renumbering the volumes from Volume I to VIII.
2. Insertion of these documents that were inadvertently left out by the print shop that included, October 18, 2006, Form 50, Request for Hearing (WCC Claim No. 0126962), October 9, 2006, Form 50, Request for Hearing (WCC Claim No. 0227098), October 7, 2006, Form 50, Request for Hearing (WCC Claim No. 0322274), Appellant's APA (WCC Claim No. 0321756), Part of Appellant's APA 15. Errata Sheet's pages 923-931, September 4, 2007, transcript of hearing before Commissioner Huffstetler, pages 1104, 1105, 1119, June 16, 2006, transcript of deposition of Gertrude Shiver, pages 1257-1264, and the medical records from Palmetto Health-The Center for Pain Management page 1441.
3. The correcting of the numbering of the Index and new Indexes applied to each volume and the unbound volumes.
4. The renumbering of pages 603-610, where 603 was renumbered with the cover sheet of WCC. File No. 9503744.
5. Errata sheet on page 922 turned upright.
6. The taking out of pages 1424-1426.
7. The renumbering of the pages starting at page 1414-1565.
8. Covers applied to reflect the numbering of the Volumes I-VIII.

With the taking out of the pages 1424-1426 and a numbering mistake there had to be corrected, there had to be a renumbering of the pages starting from page 1414 until page 1565 of Volume 8.

The unbound copies had to be straighten out to correlate with the bound copies to include amended Indexes and covers and the identifying and correcting of missing pages.

Therefore, I am asking the Court to grant me permission to correct the Records on Appeals and to accept the corrections. These were human errors and mistakes.
